PROTECTING LIFE

1) Do you support ending all public funding of entities that perform or promote abortions, such as Planned Parenthood?

2) The “No Taxpayer Funding of Abortion Act” (H.R. 18), sponsored by 198 members of Congress including the late Rep. Don Young, would codify the Hyde Amendment and establish a permanent, government-wide prohibition on federal funding for abortion. Do you support this legislation?

3) The “Pain-Capable Unborn Child Protection Act” (H.R. 1080), sponsored by 167 members of Congress including the late Rep. Don Young, would protect preborn children from abortions performed later than 20 weeks after fertilization, based on their ability to feel excruciating pain. Do you support this legislation?

4) The “Born-Alive Abortion Survivors Protection Act” (H.R. 619), sponsored by 204 members of Congress including the late Rep.
