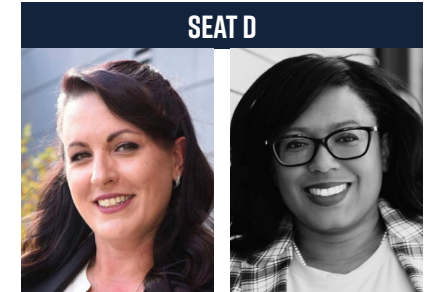

1. STOP LGBTQ INDOCTRINATION: The “Social themes in literature class” added to the curriculum last year promotes LGBTQ ideology and should be discontinued.
2. PROTECT STUDENT SPORTS: Should biological males be barred from women’s sports if they identify as female?
3. ABORTION-FREE SCHOOLS: School district employees, such as nurses, should not refer students for abortion or otherwise facilitate abortions, e.g., by transporting students to Planned Parenthood.
