- 1. STOP LGBTQ INDOCTRINATION: The "Social themes in literature class" added to the curriculum last year promotes LGBTQ ideology and should be discontinued.
- 2. PROTECT STUDENT SPORTS: Should biological males be barred from women's sports if they identify as female?
- 3. ABORTION-FREE SCHOOLS: School district employees, such as nurses, should not refer students for abortion or otherwise facilitate abortions, e.g., by transporting students to Planned Parenthood.
- 4. CRITICAL RACE THEORY: "Critical Race Theory" is a poisonous left-wing ideology that undermines American values and should not be taught in district schools.
- 5. END BIASED "DIVERSITY" TRAINING: The school district should end so-called "Diversity, Equity and Inclusion" training for employees that teaches "Critical Race Theory" and LGBTQ ideology.
