

**A RESOLUTION BY DISTRICT 27 OF THE ALASKA REPUBLICAN PARTY FINDING THAT SENATOR DAVID WILSON HAS ENGAGED IN ACTIONS DETRIMENTAL TO THE ALASKA REPUBLICAN PARTY AND TO REPUBLICAN VALUES AND GOALS BY LEAVING THE REPUBLICAN CAUCUS AND JOINING A CAUCUS IN WHICH DEMOCRATS HOLD THE MAJORITY WHEN A REPUBLICAN MAJORITY HAS BEEN ELECTED, CONTRARY TO THE VALUES OF HIS CONSTITUENTS AND THE PARTY HE DECLARED HIMSELF TO BE A MEMBER OF IN THE LAST ELECTION**

**WHEREAS**, David Wilson was elected as a Republican candidate to represent District N in the Alaska Senate, which includes House Districts 27 and 28; Wasilla, Meadow Lakes, and areas East of Wasilla, and;

**WHEREAS**, David Wilson, has abandoned his Republican colleagues in the senate by leaving the Republican Caucus and joining a Democrat-majority Caucus, and;

**WHEREAS**, Republican voters outnumber Democrat voters in District N by more than five to one, and;

**WHEREAS**, in joining a Democrat-majority Caucus, David Wilson has betrayed the voters of District N after running for office as a Republican, and;

**WHEREAS**, David Wilson abandoned the Republican Caucus without warning to the voters in his district who would have urged him to keep faith with them and with the other Republican Senators from the Mat-Su, and;

**WHEREAS**, David Wilson has joined a leftist-controlled coalition that is fundamentally at odds with the interests of residents of the Mat-Su Valley, and;

**WHEREAS**, the Democrat-majority Caucus has already announced that a majority of committees in the Alaska Senate will be chaired by Democrat legislators, even though Alaskans elected a Republican Majority in the Alaska Senate, and;

**WHEREAS**, David Wilson received \$3,000 from the Republican Senate Majority Fund in the last election, the purpose of which was to ensure a Republican Majority in the Alaska Senate, and;

**WHEREAS**, while a Republican candidate, David Wilson received a total of \$4,000 from the Alaska Republican Party, whose priorities and values he has now abandoned, and;

**WHEREAS**, the Democrat-majority Caucus has announced that it will be a binding caucus, which will obligate its members, on certain key votes, to prioritize and vote for the interests of the Democrat-majority caucus over and above the interests of Mat-Su residents;

**NOW THEREFORE BE IT RESOLVED** that District 27 of the Alaska Republican Party, hereby calls upon Senator David Wilson to immediately resign his membership in the Democrat-majority Caucus in the Alaska Senate; and

**THEREFORE BE IT FURTHER RESOLVED** that if Senator David Wilson does not resign his membership in the Democrat-majority Senate Caucus effective immediately, District 27 of the Alaska Republican Party calls upon David Wilson to resign from the legislature so that District 27 and 28 Republicans may submit names to the governor to enable Governor Dunleavy time to appoint a senator who will prioritize the will of District N voters over those of the binding caucus in Juneau; and

**THEREFORE BE IT FURTHER RESOLVED** that if Senator David Wilson has not either resigned his membership in the Democrat-majority Caucus, or resigned from the legislature, by 5pm on Friday, December 2<sup>nd</sup>, we find that Senator David Wilson has been censured by the number of voting members of District N noted below that reside in District 27, for leaving the Republican Caucus and joining a Democrat-majority Caucus when a majority of Republican senators was elected; accordingly, District 27 encourages Republican voters not to support David Wilson in any future political endeavors in the State of Alaska, and declare our intention to not endorse, campaign, or raise funds for him or for any organization which intends to support him as a candidate or appointee to partisan office; and

**THEREFORE BE IT FURTHER RESOLVED** that the Alaska Republican Party State Central Committee has undermined our district committee and district convention process by endorsing and permitting Senator David Wilson to receive money from the Alaska Republican Party, when our district rejected David Wilson's request for endorsement each and every time he applied for it, and we request an immediate revocation of said endorsement of Senator Wilson by the ARP State Central Committee; and we further request that the Central Committee in future, refrain from endorsing candidates before the candidate has been endorsed by their District; and

**THEREFORE BE IT FURTHER RESOLVED** that District 27 of the Alaska Republican Party requests that the ARP State Central Committee take such action as is permitted by the rules of the Alaska Republican Party, to withdraw support for David Wilson, and to request that he immediately return the \$4,000 given to him by the Alaska Republican Party.

\*If any portion of this resolution shall be found to be ineffective, the remaining portions shall continue in full force and effect until expressly modified by a subsequent vote of the District 27 Committee.

ACCEPTED and PASSED, this 30<sup>th</sup> day of November 2022, with 10 members of the District 27 Committee voting in favor, and 0 members of the District 27 Committee voting against.
