RE: Notice of Hearing on Request for ARP Sanction and Censure (dated 1/30/25)

Dear Senator Murkowski,

My name is Robert Wall. I reside in Sterling, Alaska, and I am currently the chair of the Alaska Republican Party (ARP) House District 8 on the Kenai Peninsula. On January 30, 2025, I received a formal written complaint (attached) from three individuals regarding your recent political actions, which included their Request for your sanction and/or censure by the ARP. The three individuals are Heidi Covey, Anita Gordon, and Wayne Ogle.

Alaska Republican Party rules, Article 7, Sections 1-5 (attached) outline the procedures to be followed when a formal complaint is received. In accordance with these rules, I have verified that the three individuals who submitted the complaint are registered Republicans, residents of District 8, and also voting members of the Republican Women of the Kenai (an affiliate organization of the ARP).

Following ARP rules, I presented these charges to the District 8 Committee on February 12, 2025. Committee members voted to move the charges forward to the other ARP Districts. (Please note: the ARP platform principle referenced in the fifth paragraph of the complaint regarding Ranked Choice Voting was mistyped as "Platform Principle #423". The District 8 committee accepted the complaint only after it was corrected to cite Platform Principle #46).

This letter serves as the required minimum 15-day notice to you of the scheduled hearing of the charges, to be held at 4:00 PM (AKST) on Wednesday, March 5. The meeting will occur in person at Pizza Paradisos (large banquet room), 811 Main St, Kenai, AK 99611, and online via Zoom (link to be provided). The Zoom meeting will be recorded.

All the ARP district committees will be invited to participate live (in person or via Zoom) or to view the recording afterwards. The three people who submitted the complaint will present it at the hearing. We request that you attend, either in person or via Zoom, to provide your response.

As per the ARP rules, each district will then independently consider the arguments and vote for or against your sanction or censure. Only if a simple majority of districts vote for sanction or censure would it occur as an action of the Alaska Republican Party.

Please contact me by Monday, February 24 to notify me in which manner you will attend the hearing on March 5 (in person or via Zoom), or if another, earlier meeting time is more convenient for you. We will do our utmost to accommodate your busy schedule.

Thank you for your attention to this matter.
